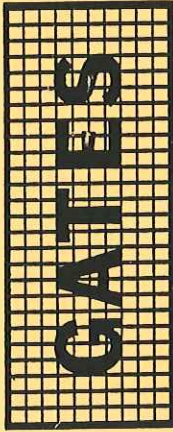

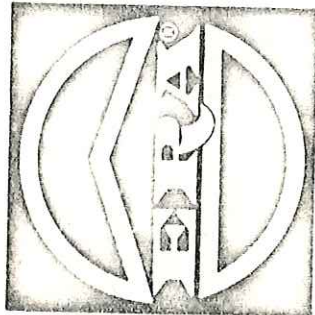

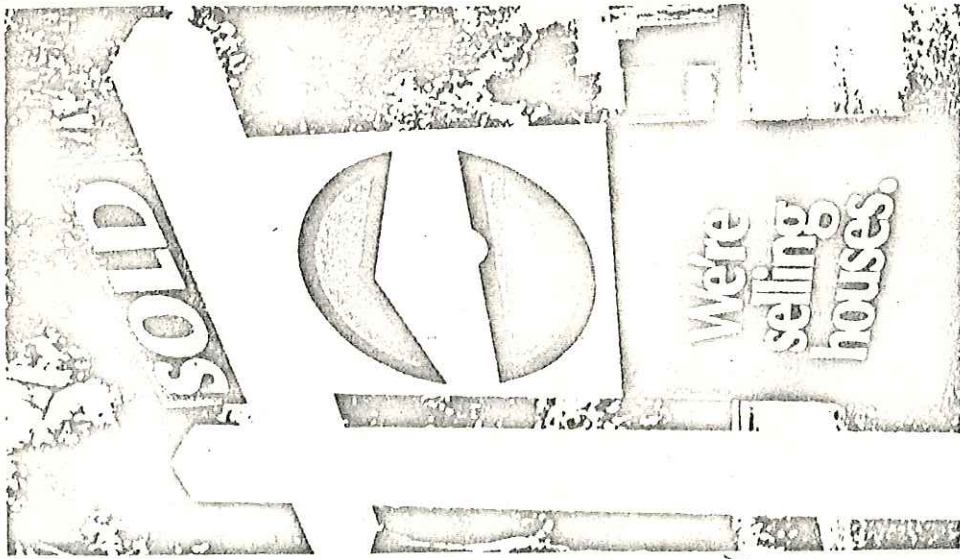

An interscholastic wrestling match is composed of three two-minute periods, for a total of six minutes. To begin the first period, wrestlers assume a neutral position on their feet. The second period is started with one wrestler choosing either the up, down or standing position. His opponent will get the same choice to begin the third period.

If a draw occurs in tournaments after the regulation time, the wrestlers will wrestle three one-minute periods. It at the end of this time there is a draw, the winner will be elected by the officials who have judged the competition using established criteria.

EXPLANATION OF COLORS

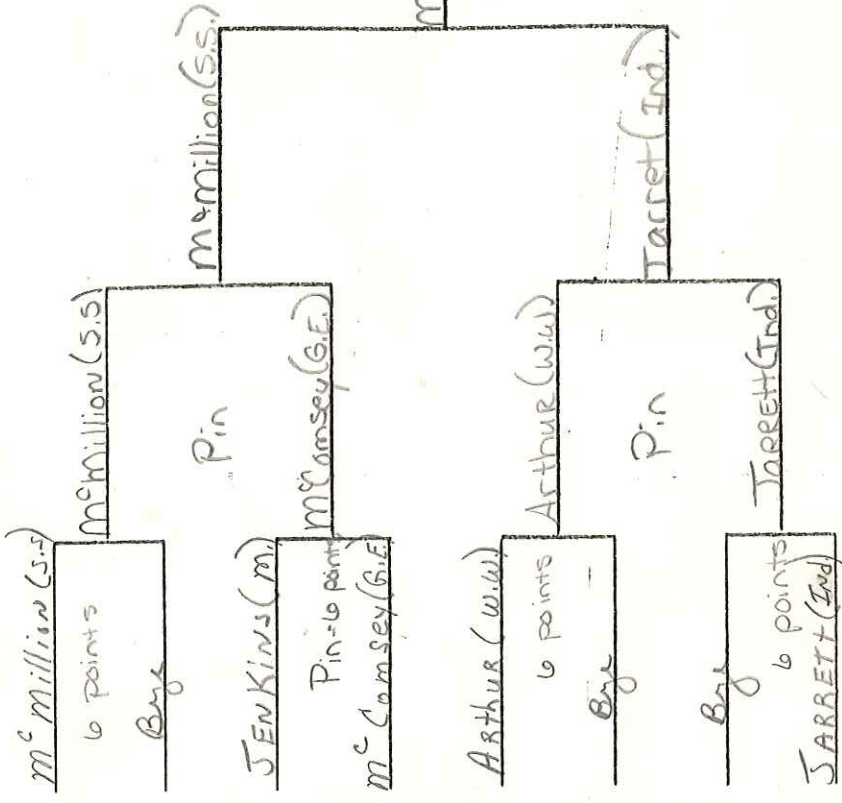
During each bout, each contestant will be wearing either a red or green anklet. These colors will correspond to the individual score accumulated by each man. Therefore, if a wrestler is wearing a green anklet, his score will appear on the green side of the individual score stand. Between the first and second periods the referee will toss a green and red disc to determine who has the choice positions. The colors of the disc will also correspond to the colors of the anklets.
