All Divisions - Saturday, March 22 2025.

**Start times:** 6U, 8U, 10U, - (Weigh-in 7:30-8:30) & wrestle at 9:30

12U, JH (7-9), Boys HS (9-12), Girls HS (9-12), Open/Masters Division (Post High School) - (Weigh-in 10:00-11:30) & Wrestle at 12:30

Age as of day of tournament - You may double bracket. - Girls in youth & JH will be paired together in weights & divisions where possible, but there are no girls only divisions except for high school.

**Registration:** By Friday, March 21, at 11:59 a.m. online only at [pywrestling.com](http://pywrestling.com)

**Registration Fee:** \$30.00 per entry **Spectator Admission:** \$5.00 Adults, \$3.00 students. **Capacity:** The tournament will be limited to the first 350 entries. 4 full mats!

Weigh-ins will also be open to all divisions Friday night from 6:00 p.m.– 8:00 p.m. (\$10.00 additional weigh-in fee)

**Format:** We will group wrestlers in a Madison style tournament brackets. Wrestlers in each age group will be grouped in a "round robin" format with a goal of 5 or 6 per group if possible. You will wrestle everyone in your group.

**Match Times:** Youth 1-1-1, JH/High School / OPEN 1 ½, 1 ½, 1 ½. Overtime – 1-minute sudden victory & one :30 second UTB

**Weights:** Enter your weight as of the day of your entry in the tournament (when you register). The day of the tournament you will need to be within 3 pounds of the weight you sent in on your registration. We can then have brackets ready to go and start on time.

**Awards:** Medals for the top three in each weight.

A singlet must be worn during weigh-ins, headgear is optional. Skin will also be checked and a PIAA Skin form, or appropriate NFHS skin form, documented within 5 days of weigh-in, must be produced for any skin condition.

A criteria will be established and posted for placing when necessary, ie., wrestlers all have a loss in the bracket.
